

### NOTICE OF ANNUAL GENERAL MEETING

Notice is hereby given that the Annual General Meeting ("AGM") of Global Capital Property Fund Limited ("Company") will be held as a virtual meeting on Wednesday, November 23, 2022, at 2:00pm AEDST.

With the enactment of the Corporations Amendment (Meetings and Documents) Act 2022 (amending Act), permanent amendments have been made to Australia's Corporations Act 2001 (Cth) to allow companies (and registered schemes) to sign and provide general meeting related documents electronically, and to use virtual meeting technology to hold general meetings, i.e., to hold "hybrid general meetings" and wholly virtual general meetings.

Having regard to social distancing requirements, the varied locations of shareholders and in the interests of the health and safety of our shareholders, directors and staff, GCPF has decided that its AGM will be held as a virtual event inline with the amendments made to Australia's Corporations Act 2001 (Cth).
